Details of the pre-application advice received

• Proposal is acceptable in principle for residential development • The main impact to be considered is to neighbouring no. 30 to the south east. • In order to mitigate any impact on no. 30 I would suggest reducing the proposal to 4 dwellings by removing the plots to the SE corner of the site, adjacent to the rear garden of no. 30. This resulting change could then enable the plot to the NE to be moved back into the site so to minimise any impact upon the front elevation outlook of no. 30. The removal of a plot may also allow for the remaining 4 plots to benefit from larger amenity garden spaces within the site whilst still maintaining suitable parking provision. • Any application should take account of noise generated from the Constitutional Club. Whilst a noise survey isn't required to validate any application, a statement setting out the nature and frequency of evening events held at the club will be useful to assist in determining any noise impact on future residents of the site. • LCC Highways have provided standing advice only – no objections. Their response is attached. • Comments received from HBBC waste and HBBC drainage are also attached.
