Please see the below response from the Ecologist.

*The hedge section near the interface with Leicester Road is overgrown and extends well beyond the property boundary. The hedgerow will be cut back in line with the boundary to maximise the width of the Cycle link. The extent of the overgrowth is depicted below and will be managed through strimming to maintain the boundary without impacting the integrity of the hedgerow. I hope this clarifies the holding objection in relation to ecology on site.*
