<b>REASON FOR RECOMMENDATION:</b>		
<ul style="list-style-type: none"><li>The development is exempt from BNG requirements under the self-build and custom build applications exemption.</li><li>This proposal has the potential to impact a significant area of roof tiles, soffits and bargeboards. There is well connected habitat surrounding this site which may connect commuting bats. Historic records from Leicestershire and Rutland Environment Record Centre indicate the presence of bats within the surrounding habitat.</li><li>A Preliminary Roost Assessment (PRA) will be required. This PRA should be carried out by a suitably licenced ecologist, and this can be completed at any time of year. Protected species surveys and appropriate mitigation are required prior to determination of this planning application, to avoid harm or reduce potential harm. (Reference: Paragraph 99 of ODPM Circular 06/2005 (Biodiversity and Geological Conservation – Statutory Obligations and their Impact within the Planning System)).</li></ul>
