Hi Jim,

I've heard back from my colleague, apologies again for the delay. Please see comments below on the new layout.

#### **Location of Proposed Development**

Westfield Avenue is currently a private road, owned by Avant Homes. Whilst the developer has Technical Approval for their site, which means that it accords with the design standards set out in the Leicestershire Highways Design Guide (LHDG). They have not yet entered into a S38 agreement for adoption of the roads.

The general layout proposed by this new development clashes with elements of the Technically Approved drawings, including the alteration to the originally proposed industrial access to the West side of Westfield Avenue, and the location and length of speed control features approved within the design. In turn, alterations to speed tables and junctions would have a knock-on impact to drainage features, such as gullies, which have already been installed on site.

The following comments are made notwithstanding the impact on the existing Technically Approved plans held by Avant Homes.

#### **Proposed Access for plots 1-12**

The developer has shown a 'Shared Access Way' serving plots 1-12. The developer has now designed this to serve the minimum 6 frontages required by the LHDG in order for the shared surface to be considered for adoption. The proposed crossing point has been moved to the south to provide a suitable location for a dropped crossing.

#### **Proposed Access for plots 13-15**

Pedestrian visibility splays now shown for proposed private drive.

#### **Proposed Access for plots 16/17/18**

Pedestrian visibility splays now shown for proposed single domestic vehicle access.

All changes are now acceptable. Although as it remains to be served from a private road (at this time), it is not yet suitable for adoption.

There was an error in the planning layout drawing uploaded but your comments noted the changes to the layout on the materials plan.

Before resubmitting, I wonder if I could have your view on the following amends to address your outstanding concerns?

- The shared access has been extended and now serves six plots (2,3,4,5,8 and 9). It is my Client's intention to seek the adoption of the road at some point in the future (accepting that Westfield Avenue will need adopting first)

- The pedestrian crossing is moved off the junction to a point south of the access

These changes are shown on the attached drawing.
