All trenches open – onto mixed sand and gravels. Photos attached. Negative apart from a big dump of modern material/rubbish in what looks like a quarry pit at the northern end of the trench furthest north. HP sauce bottles, modern pottery etc. see the 2nd & 3rd photo attached. We've done a sondage into it down to just over 1m but haven't bottomed and the sides are very unstable. Looks to be mid 20th century. We are just recording them now and then will backfill later today if you're happy with that?
