The erected structures are as follows:

1. Summerhouse:

Dimensions: 6.5m x 3.95m with a maximum height of 2.30m.

Materials: The summerhouse is constructed from timber with a sloped roof. It will feature 3 glazed doors on the front elevation to allow natural light.

Location: The summerhouse is positioned 6.8m from the maisonette at the rear of the garden.

Use: The summerhouse will be used for ancillary purposes to the main dwelling, including recreational activities such as home office or relaxation area. It will not be used as a separate residential dwelling or commercial use.

2. Shed

Dimensions: 2.5m x 4m with a maximum height of 2.30m.

Materials: The shed is constructed from timber with a pitched roof.

Location: The shed is located adjacent to the summerhouse and 6.8m from the maisonette boundary.

Use: The shed will be used for general garden storage and incidental purposed related to the dwelling, such as storage of garden tools, equipment and outdoor furniture.

Both structures are designed to be in keeping with the overall character of the garden and will not cause any undue harm to the neighbouring properties in terms of light, privacy, or noise. The summerhouse and shed will remain incidental to the enjoyment of the main dwelling and will not be used for residential accommodation or commercial use.

The site in question is a residential garden located at 7 Red Hall Road, Barwell which serves as the private outdoor space for the existing dwelling. The application proposes the addition of two structures:

Summer House: This will serve as a leisure and relaxation space for the residents, to be used for recreational purposes such as reading, socializing, and hobbies. It will not be used for permanent accommodation or any form of commercial activity. The design and materials will complement the existing garden environment.

Shed: The shed is intended for storage of garden tools, equipment, and outdoor furniture, and will provide a secure space for maintaining the upkeep of the garden. This structure will not be used for any residential or business purposes.

Both structures will enhance the residential amenity of the property without altering the use of the site, which remains as a private, non-commercial residential garden.

The erection of the summerhouse and shed is small in scale and located in a domestic garden. This is considered minor development and does not involve the removal of trees, hedgerows, or other ecologically significant habitats. The garden is not within a designated ecological area, and the structures are ancillary to the enjoyment of the property. Additionall, the 10% biodiversity net gain requirement has not been fully implemented for minor developments, and the proposal falls within the exemptions outlined under Schedule 7A, Paragraph 13 of the Town and Country Planning Act 1990 (as amended). Therefore, I believe the Biodiversity Gain Condition does not apply to this proposal.
