T3 - SILVER BIRCH: BETULA PENDULA  
PLANTED 8-10CM GIRTH

T4 - CHERRY: PRUNUS AVIUM PLENA  
PLANTED 6-8CM GIRTH

T5 - PEAR: PYRUS COMMUNIS  
PLANTED 6-8CM GIRTH

T6 - ELDER: SAMBUCUS NIGRA  
PLANTED 8-10CM GIRTH

PROPOSED HEDGE PLANTING MIX: HPM

HAWTHORN: CRATAEGUS MONOGYNA 75%  
HOLLY: ILEX AQUIFOLIUM 10%  
BLACKTHORN: PRUNUS SPINOSA 10%  
DOG ROSE: ROSA CANINA 5%

ALL SPECIES TO BE PLANTED 300mm HIGH AND 450mm APART

ELDER: SAMBUCUS NIGRA 20%  
HAZEL: CORYLUS AVELLANA 20%  
GUELDER ROSE: VIBUMUM OPULUS 20%  
JAPANESE CAMELIA: CAMELIA JAPONICA 20%  
LAVENDER: LAVANDULAR 20%

ALL SPECIES TO BE PLANTED 2 - 4CM GIRTH

BRADSTONE WOBURN RUMBLED IN GRAPHITE 134mm

Landscaping plan to accord with planning consent  
ref: 21/00402/OUT

Field to the north, but within the red line, is to  
continue in agricultural use as per the planning  
consent. No additional planting to be considered  
in this area.

Community car parking provided to require no  
digging for the preservation of neighbouring trees  
and their associated RPA's.

Purple line indicates extent of area outside of  
private ownership and is to be managed and  
maintained by a third party contractor.

Amendments:

- Areas proposed for spring bulb planting shown  
highlighted yellow.

Proposed Species mix:

Snowdrop - Galanthus  
Bluebells - Hyacinthoides non-scripta  
Daffodils - Narcissus  
Wood anemones - Anemonoides nemorosa  
Wild Garlic - Allium ursinum

To also be planted in the first season following  
completion of the development.

- Area of fencing removed at site entrance and  
replaced with hedgerow.

- Hedgerow also planted along the southern  
boundary, of the most southern property, to  
screen fence from future resident.

09/07

- Brick wall with fence above removed from  
courtyard and replaced with native hedge mix.

- Block paving guest parking & path removed and  
replaced with grass.

- 2 Silver Birch trees added along Eastern  
boundary.

11/07

- Solid green rectangles indicating planting of  
native hedge to replace existing palisade fence on  
completion of development.

21/07

- Community parking and access area proposed to  
be a grid system (grasscrete), as shown hatched,  
for protection of RPA's.
