3. Description of the Proposal

Please describe the proposed development, including any change of use:

The proposal seeks planning permission for the change of use of the existing Westfield Community Centre from its current lawful use as a community facility (Use Class F2) to a Special Educational Needs (SEN) school falling within Use Class F1 (Learning and Non-Residential Institutions). The existing building was originally constructed and used as a school and is well suited in terms of its layout, access, and scale to support a return to educational use. The proposal involves no external alterations to the building. All works will be internal and focused on converting the layout to meet the specific requirements of an SEN school, including classrooms, therapy rooms, staff areas, and support spaces. The school will accommodate up to 75 pupils aged 5 to 16, all of whom will have an Education, Health and Care Plan (EHCP). The provision will be highly specialised, supporting children with a range of complex needs including autism and social, emotional and mental health (SEMH) difficulties. The school will employ approximately 40 staff, including teachers, learning support assistants, therapists, and administrative personnel. Access to the site will be retained from Rosemary Way, with the existing one-way traffic system and tarmac parking areas maintained and managed to ensure safe and efficient circulation. Dedicated drop-off zones and minibus parking will be provided to support local authority transport arrangements. The proposal provides a high-quality, much-needed SEN education facility through the sensitive and appropriate reuse of an existing community building, with no adverse impacts on neighbouring amenity or the local highway network.
