Afternoon Ashleigh,

Always happy to work collaboratively. Nevertheless, I don't think it is helpful to agree indicative dates as a placeholder. Once we understand exactly what you require to make your decisions then I will be happy to agree an extension of time in order for this to be suitably considered. To aid this, perhaps you could confirm which consultee responses you are still awaiting?

I attach a response from our ecologist, clarifying the recommendation of a NLMS. I will shortly forward a revised BNG plan showing the tents as buildings (although this is for BNG purposes only, they will be demountable and not have a degree of permanence for planning purposes).

I do note the response from the highways team. To address this, we will be providing a revised site plan removing the front boundary fence, and we will be providing details on trip generation.

With regards to the parking for the glamping pods, the intention is that one parking space is allocated per pod. It is envisaged that pods will be sleep a maximum of four (2 adults, 2 children) and will be limited to 1 family per tent.

If you could come back to e, I'm happy to continue to work towards a positive determination.
